Two of the buildings are currently used by a composting business, one furniture storage, and the other for car sales and enhancement. None of the businesses add additional traffic through the village, however this may change with future occupiers. An objection has been raised by Highways to \$\frac{\$0691/19}{FL}\$ the other application that is awaiting a decision at Weston Woods Farm, due to it not being supported by sufficient transport information to demonstrate that the proposed development would not be prejudicial to the satisfactory functioning of the highway. Proposal that a comment is made requesting a traffic management plan is put in place as a condition that vehicles over 3.5 tonnes do not travel through the village to access the site.
